Due to Deadlock, entire world, including UN itself, all 193 member Nations & Public at large, is trapped to continue 'as it is' (whatsoever severe Crimes may be). So no one on Earth can ever be a competent authority to understand this intensely advanced, unknown & untouched subject matter, with their mindset stuck in 18<sup>th</sup> Century, forever.

Now, it is compulsory for only and only one individual UN-SG to take time to understand relevant to his domain & resolve complex situation within his sole jurisdiction. Essential details of complex situation are simplified in attached annexure.
