- Ultimatum—To Pay the 'Fine' until.....Mandatory Now

Greetings.

As mentioned in my previous letter dated 6<sup>TH</sup> April,2018-- this Medical Doctor is the First-time ever-- the justified counsel of the most powerful Administration of Million Year Institution on Earth—The Medical Sciences. Unquestionable—functioning of this Administration is absolutely intricate Science and Law and Justice, with zero sentiment, meant for real Human people. Past Million years, we have been following this Administration of our parent Institution for 'Existence' on Earth—starting from Day one the First Human was born—with no exception and contradiction.

**To terminate** the submitted issue of ongoing Violation of Million Year Laws, lawfully enforced by UN constituted Statute of International Court of Justice, ICJ Laws, Hague, Netherland [http://legal.un.org/avl/pdf/ha/sicj/icj\\_statute\\_e.pdf](http://legal.un.org/avl/pdf/ha/sicj/icj_statute_e.pdf) , (Primary Judicial Organ of UN) ---only the Secretary General of United Nations being the Chief of UN Administration has the Sole Constitutional authority to take action. With no response over 18 years—obviously a long period of time in digital era-- since the time of first official acknowledgment of this Global issue, in year 2000-- the UN Administration (including 193 member Nations) has failed in their duty to brief UN-SG, to perform his designated sole constitutional duty in the world. In accordance, illegal activities legally enforced by UN Laws--will continue forever, till the end of time.

**No more Acceptable with Zero Tolerance by the Administration of Million Year Institution:** Being the counsel of the Million year Administration—this Medical Doctor is duty-bound (just like UN counsel is duty-bound for their UN Administration Laws ) to dogwatch, that nobody violates Laws of Million year Institution—Fundamentals of Medical Sciences—because this is the vital necessity for Existence of entire Humankind. Every civilized person is accountable to pay the 'Fine' for violation of a Law, in escalating amount with each passing day-- until illegal activities are terminated, with no exception.

**Legitimate Gross, Grave and Obvious reasons to Justify-- the 'Fine' to be paid by UN-SG on behalf of UN administration—**

- Obviously, nobody in the world has authority to comment or take action on behalf of the sole constitutional duty of the Chief. Then...Why to delay ?

Un-denied—so far, the world understands and studies the Fundamentals of Medical Sciences—the Laws of Million year Administration—to get Degree in Medicine and Practice. When Law exists, obviously the Justice also exists as well. 1. 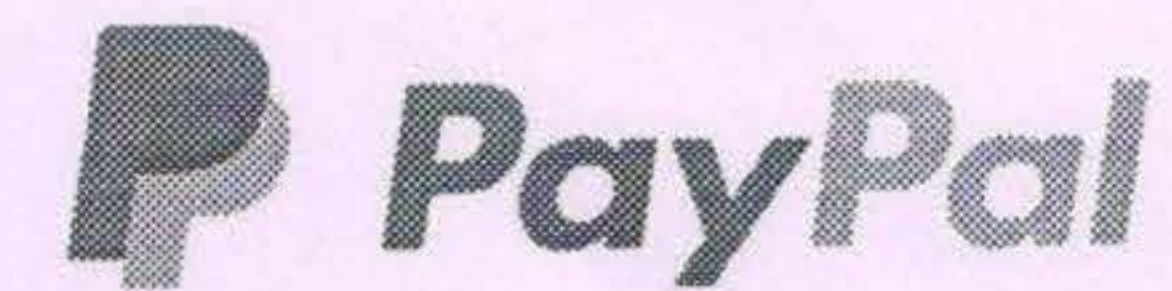
