- 2.Bound by Law: None of the country could protect these children even after repeated PIL all over the world. This Public Interest Litigation is the evidential proof. The number of children is fast growing with ever escalating divorce rates in Court of Law.
- 3.Bound by Law: This Child Custody issue is the Customary world Law of International Court of Justice Article 38 (b). Hague Netherland.
- 5. Bound by Law: Thus to traumatize child is Legal and no remedy can be implemented by Government to protect children because that's illegal.
- 6. Bound by Law: Its legal for all 193 United Nations member State Nations, Head Quarter, New York, United States of America. India is Founding member among 193 Nations.
- 7. Bound by Law: Root cause of children's painful sufferings is the Deadlock between two Laws (never heard before) is linked to Deadlock between two Laws in UN Charter —the foundational treaty that prevails all other treaties.

- 8. Bound by Law: This UN Charter is highest constitution of manmade Law, Agreed and Signed by all 193 UN member Nations with United Nations. Both signatories Chief of United Nations Administration AND All 193 UN member Nations (Government) National Leaders are political organizations. - 12. Bound by Law: Its Global issue and there is no Global Court of Justice nor any mechanism/avenue to protect children in Court of Law, so far.

- 13. - 14. - 16. - 17. Bound by Law: Child Custody Granted is endorsed by Judiciary so only Judiciary alone is accountable and responsible to protect children in legal way.
- 18. Bound by Law: Existing judiciary of the entire world is 'all set' to continue 'as it is' destroying Lives of Millions of Children —the future of all Nations at grass root level, whatsoever dangerous it may be.
- 19 Bound by Law:. Seriously dangerous is the Justice granted in child custody issue under the highest non judicial system and a document of few pages, Laws of UN Charter locked in National Treasury of United States of America PLUS no one can talk about it so how do we protect these children trapped in problem of judiciary itself.
- 20. Bound by Law: With no exception and contradiction each and every individual in the world will continue to contribute its hard earned money to Public Purse Money—TAX Money both Direct and Indirect Taxes, includes Taxes on every bottle of drinking water and bread, infant food Newly born.

- 27. Bound by Law: In accordance to Million Year Law the child is not a one-day product.
